CITIZENS "MINUTE WITH COUNCIL"

Denis Robson spoke regarding theft around town. He is concerned by the number of Bylaw officers in Hinton and suggested 1.5 bylaw officers and the hiring two additional RCMP officers to try and get theft under control.

Craig Lucas spoke to Council regarding theft and is looking at bringing Citizens on Patrol to the community. He will be meeting S/Sgt Murphy tomorrow to discuss.

David Robson spoke to the rehabilitation program in Hinton and wondered what the plans are for addressing issues and helping these individuals.

Wayne Mayan was a victim of crime as he was robbed on August 22nd. Mr. Mayan indicated that the RCMP felt there was nothing they could do until they catch the individual in the act. He feels there needs to be two detectives assigned to try and solve the crime issues as the RCMP are too busy with other activities.

Brad Bancroft spoke to Council regarding the Atco franchise fees report coming to Council today. He feels it is a hidden tax on citizens who live in the community.

Nicole Humphries was also a victim of theft and didn't realize how big this issue was until it happened to her. She indicated she has been told by the RCMP in various communities there is nothing they can do; their hands are tied if there is no evidence and they are bound by the law. She feels this should change.
