



**TOWN OF HINTON
BYLAW #796-5**

**BYLAW OF THE TOWN OF HINTON IN THE PROVINCE OF ALBERTA
TO AMEND BYLAW No. 796 WHICH PROVIDES FOR THE
OPERATION AND MAINTENANCE OF A CEMETERY FOR
THE TOWN OF HINTON.**

WHEREAS the Town of Hinton does own a parcel of land registered plan of subdivision 5781KS and known as the Woodlawn Cemetery.

AND WHEREAS this cemetery site has been approved by the Provincial Board of Health under Final Certificate of Approval No. 797 dated the 29th of April 1959.

AND WHEREAS Council deems it necessary to change certain parts of Bylaw No. 796-4 in order to clarify.

NOW THEREFORE the Municipal Council of the Town of Hinton in session duly assembled hereby enacts as follows:

Part 1: Interpretation

1. TITLE

1.1 This Bylaw may be referred to as the Cemetery Fee Bylaw

2. DEFINITIONS

2.1 "Act" means the *Municipal Government Act*, R.S.A. 2000 c. M-26, as amended.

2.2 "Burial" shall mean the excavation of a grave to the required depth and size, back filling of the grave and the removal of any excess earth.

2.3 "Fee" is the charge levied for services provided through the Town of Hinton.

2.4 "Regular Hours" is Monday through Friday, 9:00 a.m. to 2:00 p.m.

Part 2: Application

3. PURPOSE

3.1 The purpose of this Bylaw is to allow for:

a) Change the fees set December 4th, 2012, through adoption of Bylaw No. 796-4.

4. CLAUSES TO BE INSERTED

4.1 The following clause be inserted into Bylaw No. 796 as follows:

The fees and charges by the Town for plot, the opening and closing of graves for burial purposes, purchasing a Niche in the Columbarium, opening, and closing of a Niche shall be governed by the fees set out in the attached Schedule "A."

5. **SEVERABILITY**

5.1 If any portion of this Bylaw is found by a court of competent jurisdiction to be invalid, such portion shall be severed from the Bylaw, and the remainder is to remain valid.

6. **REPEALS AND COMING INTO FORCE**

6.1 Bylaw No. 796-4 and all amendments thereto are hereby repealed upon the coming into force of this Bylaw.

6.2 This bylaw shall take effect on the final day of passing.

READ A FIRST TIME THIS 4th DAY OF April 2023.

READ A SECOND TIME THIS 4th DAY OF April 2023.

READ A THIRD TIME THIS 18TH DAY OF April 2023.

Schedule A Cemetery Fee Schedule Bylaw No. 796-5

Purchase of Grave

Single Grave	\$450.00
Child Grave (10 years and under)	\$225.00
Veteran Grave	\$225.00

Each grave can accommodate one casket burial plus up to four cremations or four cremations in total. Grave size 12' x 5'.

Fees for Burial or Niche Purchase (service during regular hours)

Burial (casket)	\$800.00

Burial (urn)	\$425.00

Outside of regular hours, an additional fee will be added to the casket and urn burial fee	25%

Columbarium Niche	\$1,700.00
