**BYLAW OF THE TOWN OF HINTON IN THE PROVINCE OF ALBERTA
TO PROVIDE FOR PLANNING AND DEVELOPMENT FEES
CHARGED BY THE MUNICIPALITY
FOR DEVELOPMENT PERMIT, SUBDIVISION AND SERVICES**

WHEREAS the Municipal Government Act, R.S.A. 2000, c. M-26 (hereinafter referred to the "Act") as amended from time to time, provides that a municipality may pass bylaws for municipal purposes respecting services provided by the municipality; and

WHEREAS the Act provides for the establishment of fees for licenses, permits and approvals by bylaw;

NOW THEREFORE the Council of the Town of Hinton, duly assembled, hereby enacts, as follows:

1. That the Development Services Fees attached hereto and forming part of this Bylaw as Schedule "A" represents the fees applicable to the Development Services Department provided by the Town of Hinton.
2. That this Bylaw comes into effect upon receiving third and final reading.

- Safety Codes Permits – Fees are GST Exempt
- Retained for Cancelled Permits: If no inspections conducted, 50% of permit fee retained or \$55.00 – whichever is greater & no refund of Safety Codes Fee. If inspections conducted, no refund.
- Commencing construction prior to Building Permit Fee Issuance: Double the fee
- The fee for each permit shall be payable upon receipt of the permit application. Each safety permit is subject to a 4% Safety Code Levy fee (SCF). The minimum Safety Code Levy fee is \$4.50 to a maximum of \$560.00.
