**BYLAW OF THE TOWN OF HINTON  
IN THE PROVINCE OF ALBERTA  
TO ESTABLISH FEES  
FOR HOME SUPPORT PROGRAM SERVICES**

**WHEREAS** the Municipal Government Act, R.S.A. 2000, c. M-26 and amendments thereto, authorizes a Council to set fees;

**NOW THEREFORE** the Municipal Council of the Town of Hinton in session duly assembled hereby enacts as follows:

1. That Council set fees for home support services provided to residents of the Town of Hinton as per Schedule "A" attached.
2. Schedule "A", forming part of this bylaw, may be amended by resolution of Council.
3. This bylaw shall take effect on the final day of passing.
